Shares of Class A common stock are entitled to one vote per share. Shares of Class B common stock are entitled to 20 votes per share. The Class B Common Stock is convertible at the option of the holder to Class A Common Stock at a 1:1 ratio. Assuming full conversion of all the currently outstanding Class B Common Stock, the 16,576,319 shares of Class A Common Stock would represent 5.91% of the total Common Stock outstanding.
